

Power Steering Products **Limited Warranty Statement** Limited Lifetime

Warranty Terms. BBB Industries™ Power Steering units (including Steering Gears, Rack and Pinions and Pumps) (collectively, “Products”, or individually, “Product”) are warranted by BBB Industries, LLC (“Seller”) to be free from defects due to faulty workmanship or defective materials and BBB Industries offers a limited lifetime warranty. This warranty applies to Products designed for cars, vans, light trucks, domestic and import applications only. This warranty does not apply to normal wear and tear nor Products that have been dismantled, altered, repaired, misused, damaged, neglected, improperly installed or maintained, installed on a vehicle for which it was not designed, installed with the incorrect steering fluid (use only Original Equipment recommended Power Steering fluid), or subject to abuse or used in applications for which it was not designed. This warranty is limited to the original purchaser and the original vehicle on which the Product is installed and is not transferable. The term “original purchaser” shall mean a purchaser who purchased the Product directly from Seller or Seller’s authorized reseller of the Product. Seller reserves the right to discontinue any Product at any time, and to substitute any part or component thereof.

How To Exercise Your Warranty. Any claims for defects under this limited warranty must be submitted promptly to the authorized distributor from which the Product was purchased, together with the Product and proof of purchase. There shall be no obligation under this warranty unless the Product is returned with all original subcomponents. The right of Seller to inspect a Product and/or subcomponent or power steering system to determine if it has failed because of a defect in workmanship or materials is expressly reserved. Any Product determined in the sole and absolute discretion of the Seller’s authorized warranty inspector to be defective within the warranty period provided for herein will be repaired, replaced, or credited as determined at the discretion of the Seller’s warranty inspector. The original purchaser will be responsible for all return shipping charges and related costs.

Warranty Exclusions. BBB Industries™ will not reimburse the original purchaser for the costs of removing the failed or defective part, returning that part, installing the replacement unit or replacing any parts, or for any other expenses, charges or damages.

THE WARRANTIES CONTAINED HEREIN WITH RESPECT TO EACH PRODUCT ARE IN LIEU OF ALL OTHER WARRANTIES, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, ANY EXPRESS OR IMPLIED WARRANTY OF MERCHANTABILITY, ANY EXPRESS OR IMPLIED WARRANTY OF NON-INFRINGEMENT OF PATENTS, TRADEMARKS, TRADE DRESS, COPYRIGHTS OR TRADE SECRETS, OR ANY EXPRESS OR IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE, OR ANY OTHER OBLIGATION OR LIABILITY OF, OR ON THE PART OF, SELLER. SELLER HEREBY DISCLAIMS ALL OTHER WARRANTIES, GUARANTIES OR REPRESENTATIONS OF ANY TYPE WITH RESPECT TO EACH PRODUCT NOT STATED HEREIN, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, ANY WARRANTY OF MERCHANTABILITY, NON-INFRINGEMENT, OR FITNESS FOR A PARTICULAR PURPOSE.

This warranty does not cover labor charges or cover the cost of any additional components and labor required to restore the defective Product or power steering system to its proper operating condition. All incidental or consequential damages, from any cause whatsoever, and any such liability, is disclaimed to the full extent permitted by law. The sole remedy for any claimant under this warranty shall be the repair, replacement, or credit for the Product determined to be defective by the Seller’s authorized warranty inspector (and in the sole and final discretion of such authorized warranty inspector). Any liability for damage arising out of or related to a Product, the purchase of a Product, or the installation of a Product (whether for breach of contract, tort (including, without limitation, any claim based on negligence or strict liability), or any other claim or cause of action), is limited to the replacement or credit of the Product (in the sole discretion of the Seller’s authorized warranty inspector). The liability limitations contained in this warranty shall inure to the benefit of all sellers, retailers, distributors, suppliers, wholesalers and manufacturers of the Products and their sub-components.

This warranty may not be modified in any respect unless such modification is in writing, expressly states that it is a modification of this warranty and such modification is signed by an officer of BBB Industries, LLC.
