Limited Lifetime Warranty

Warranty Includes: Power Brake Boosters; Light Duty Vehicles

What the warranty covers: NAPA Brakes warrants all NAPA Power Brake Boosters products to be free from defects in material and workmanship during the intended service life recommended by the vehicle manufacturer. This warranty is non-transferrable, this warranty becomes void upon vehicle title transfer, meaning that if the title is transferred this warranty is terminated. New vehicle and equipment warranties remain in effect during the use of NAPA Brakes products. The NAPA Brake Parts warranty does not cover any loss due to misuse, alteration, modification, accident, abuse, neglect, normal use wear, improper application, or installation of the products. This warranty only applies to NAPA Brake Parts products installed on passenger cars, vans, and light trucks. This warranty does not apply to products installed on vehicles or equipment used for the following: towing, racing, public service, security, government, off-road/off-highway recreation, off-road/off-highway competition, fleet, or commercial purposes, or if used on any non-automotive, marine, commercial, industrial or aviation application. This warranty does not cover any loss or liability for incidental or consequential damage that may have been caused by a breach of this written warranty. NAPA BRAKES EXPRESSLY DISCLAIMS ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTIBILITY AND OF FITNESS FOR A PARTICULAR PURPOSE. The foregoing states NAPA Brakes' entire and exclusive liability and the buyer's exclusive and sole remedy for any damages or claim made in connection with the sale of NAPA Brake Parts products. No other warranty, express or implied, shall exist.

If the NAPA Brake Parts product is found by NAPA Brakes to be defective in material or workmanship during the period of the intended service life recommended by the vehicle manufacturer, NAPA Brakes will replace the defective product with a replacement NAPA Brakes product at its option.

Replacement guidelines: In order to obtain equipment replacement under this warranty, the customer must, within 14 days after discovery of this defect or failure, submit a claim to a NAPA AUTO PARTS Store. The customer must allow the NAPA Brake Warranty and Failure Mode Analysis Department to examine the NAPA Brake Parts product and, if required, the vehicle or additional equipment, to determine the extent of damage and whether it was caused by a defective NAPA Brake Parts product covered under this warranty. Products must be returned, in their original and unmodified condition, to the place of purchase for warranty consideration.

NAPA Brakes will replace the NAPA Brakes Parts product found not to conform to this warranty provided that the customer follows this warranty filing procedure:

- 2. Submit all pertinent paperwork, including copies of the original purchase receipt, repair orders, pictures (if applicable) and all paperwork relating to the incident.
