

Bosch Wheel Service Limited Warranty

Robert Bosch LLC ("Bosch") warrants **Bosch wheel service equipment** purchased from it to be free from defects in material and workmanship for a period of one year from the date of purchase. Bosch will cover all parts and labor for a period of six months and will cover the cost of replacement parts only for an additional six months. Exceptions to this warranty are listed below:

The warranty period for the TC220S tire changers is six months parts and 90 days labor.

The warranty period for the Bosch Easy Combo (WBE 4100/TC220S) is six months parts only.

Bosch will, at our option, repair or replace at no charge such products which, under normal conditions of use and service, prove to be defective in materials and/or workmanship. Any defects must be reported within five days of discovery. This warranty is limited to the original consumer purchaser and is not transferable. Repaired and replacement products shall assume the identity of the original for purpose of this warranty and this warranty shall not be extended with respect to such products.

Specifically excluded from this warranty, are failures caused by misuse, neglect, abuse, improper operation or installation, unauthorized service or parts, or failure to follow maintenance instructions or perform normal maintenance activities. This warranty does not apply to any components or parts which are consumed, used or experience wear during the products ordinary operation, including equipment calibration. This warranty sets forth your exclusive remedies with respect to the products covered by it. Bosch shall not be liable for any incidental, consequential, special or punitive damages arising from the sale or use of any products, whether such claim is in contract or tort. No attempt to alter, modify, or amend this warranty shall be effective unless authorized in writing by an officer of Robert Bosch LLC.
