## All NAPA Timing Products Except Hi-Performance Products

### Limited Lifetime Warranty

NAPA Timing warrants its products (except Hi-Performance Products) to the original retail purchaser, to be free from defects in material and workmanship under normal operating conditions for as long as such purchaser owns the vehicle in which such product is originally installed. This warranty does not apply to products which have been altered, repaired or improperly installed.

NAPA Timing will, at its option, repair, replace, or refund the purchase price of any warranted product which proves to be defective in material or workmanship, provided (i) the original purchaser returns the defective product, transportation charges prepaid, to NAPA Timing with proof of purchase and (ii) NAPA Timing's examination discloses to its satisfaction that the product was defective.

No charge for labor, freight or other expenses incurred in the repair, removal or replacement of any product claimed to be defective will be paid by NAPA Timing and NAPA Timing shall not be liable for any expense incurred by the original purchaser to remedy any defect in the product.
